We were able to implement key infrastructure improvements like online scheduling that allows clients to schedule appointments themselves, freeing up a huge chunk of time and complexity by staff. We added two new key positions: a second DOJ representative and a partnership coordinator to help us improve secondary services and referrals.

After all the COVID cautions, we were able to get back into schools, libraries, and churches to talk about immigration and Immigrant Hope. We saw more people and helped more people. We ourselves were blessed by these same people, many of whom have become friends.

On a selfish note, I was blessed to meet, cry, laugh, and pray with people who would never otherwise have stepped into a church. LGBTQ, Muslims, Hindus, Buddhists, atheists ...so many wonderful people. Our "categories" would have kept us apart, except for this mutual connection with immigration. My life is richer, and my joy more complete, having people with much wider lives and experiences than my own.

Dear friend,

I hope your 2023 is off to a great start! The new year is a time to reflect on the wins of the previous year and be intentional about what is to come. I want to share encouraging news from your involvement and the many others who have followed and joined Immigrant Hope Atlanta's journey. The most exciting news is the number of lives you've changed through viewing, sharing, and contributing to low-cost immigration legal services. In fact, our legal team on the ground in Georgia informed me that we've seen a 23% increase in families signing up to receive service!

Throughout 2022, you helped 160 immigrants understand their legal rights and the best way to pursue temporary or permanent residency in the U.S. Many of these families have traveled from countries such as Afghanistan, the Democratic Republic of Congo, Venezuela, and Iraq - six more countries of origin than the 33 nationalities served in the previous year!

While there is much to be thankful for in the past year, with your help we can meet a vision to more than double our impact in 2023! Our strategic vision will see an expansion of program sites and case types while adding two new Department of Justice representatives to our regular office hours. We know we will see so many more lives changed.



LEGAL SERVICES





Of the **129 new cases** Immigrant Hope Atlanta took on in 2022, **61%** happened in the second half of the year. **June** and **December** were our busiest months!

Additional facts:

- 52% female clients and 48% male clients
- We saw 39% family-related, 18%
 DACA-related, 9% naturalization-related, and 6% crime-related case types
- Our clients were between the ages of 10-19 (6%), 20-29 (25%), 30-39 (24%), 40-49 (15%), 50-59 (16%), 60-69 (7%), and 69+ (5%).



VOLUNTEERS

In 2022, we had **12 volunteers** in our legal program and **2 volunteers** in our public education program. Legal program volunteers contributed **2,351 volunteer hours**, which is an average of **196 hours apiece** or about **4 hours a week.** They worked on approximately **250 cases.** Our public education volunteers contributed **36 volunteer hours.** Additionally, our volunteer pool is composed of **42% immigrants.**






REVENUE \$170,320
